

ARTHRITIS AND CLINICAL IMMUNOLOGY/CLINICAL OPERATIONS - AFTER BEING REDESIGNATED IN 2024 AS ONE OF ONLY SEVEN AUTOIMMUNITY CENTERS OF EXCELLENCE RECOGNIZED BY THE NATIONAL INSTITUTES OF HEALTH, OMRF CONTINUED TO BLAZE NEW PATHS IN RESEARCHING AND TREATING AUTOIMMUNE DISEASES. THE FOUNDATION RECEIVED A TRIO OF MAJOR NEW FEDERAL GRANTS TO STUDY THESE ILLNESSES. TOGETHER, GRADUATE STUDENTS AND POSTDOCTORAL FELLOWS IN THIS PROGRAM EARNED 11 RESEARCH GRANTS AND FELLOWSHIPS, WHICH COULD BLAZE NEW TREATMENT PATHS FOR ILLNESSES RANGING FROM HEART ATTACK AND STROKE TO DIABETES-RELATED VISION LOSS.
