ARTHRITIS AND CLINICAL IMMUNOLOGY/CLINICAL OPERATIONS - OMRF CONTINUED TO BUILD ON ITS NATIONAL LEADERSHIP IN AUTOIMMUNE DISEASE RESEARCH AND CARE. IN 2025, PHYSICIANS IN THE FOUNDATION'S CLINICS TREATED MORE THAN 3,000 PATIENTS LIVING WITH CONDITIONS SUCH AS LUPUS, MULTIPLE SCLEROSIS AND RHEUMATOID ARTHRITIS. AT THE SAME TIME, OMRF EXPANDED ITS PORTFOLIO OF CLINICAL TRIALS, SERVING AS A LEADING SITE FOR SOME OF THE FIRST U.S. STUDIES DESIGNED TO PREVENT AUTOIMMUNE DISEASES BEFORE SYMPTOMS APPEAR. DR.
